Re: Follow up - Access Information for CHRIS Modifications Training

Please see below for access information for the Office of Licensing CHRIS Modifications training. This training will encompass everything from acquiring a DELTA login to the revisions made to align CHRIS with the Office of Licensing <u>Emergency Regulations for Compliance with Virginia's Settlement Agreement with US DOJ</u> ("Emergency Regulations"). The training will focus on the improvements DBHDS has made to better manage and report incidents. In addition, the training will cover how to report both serious incidents and deaths into CHRIS including specific scenarios to better demonstrate CHRIS functionalities to providers.
