#### Therapeutic Behavioral Consultation Services

- Therapeutic behavioral consultation services may be helpful for individuals who have challenging behavior.
- These services typically consist of:
  - Conducting a functional behavioral assessment
  - Developing of a BSP
  - Focusing on decreasing challenging behavior
  - Increasing desirable/replacement behavior
  - Training for supporters on plan implementation

#### 30 Days from ISP to Service Authorization



### Goal: Service Authorization within 30 days of ISP meeting

A behaviorist is:

- Board Certified Behavior Analyst/Licensed Behavior Analyst (BCBA/LBA) and Board Certified Assistant Behavior Analyst/Licensed Assistant Behavior Analyst (BCaBA/LABA)
- Positive Behavior Support Facilitator (PBSF)
- Individuals recognized by a positive behavior supports organizations
- Clinician qualified to provide psychological consultation, per regulations 12VAC30-122-550

Learning Goal Review

The August 1, 2024, update to WaMS will change the required responses related to Therapeutic Behavioral Consultation services.

An individual identified as in need of therapeutic services should be connected to a behaviorist within 30 days. An authorization needs to be in place within 30 days.
