Announcing a NEW OIH-HSN Training on the COVLC

Medication Administration Overview



This 1-hour training provides best-practice information for safe medication administration; identifies adverse drug events; reviews risk factors involved in medication administration; examines the impact of medication administration on individual with intellectual and developmental disabilities (IDD); distinguishes additional issues related to adverse drug events and the IDD population; discusses ways to reduce risk of harm; defines a Medication Administration Record (MAR) as written in Virginia Code; differentiates between an Unlicensed Persons (UP) vs. Registered Medication Aide (RMA) via Virginia Board of Nursing regulations, and Virginia Code; and reviews FDA guidelines for proper handling of medications to include storage and disposal.
