

REVIVE! FAQ Sheet

What is **REVIVE**!?

REVIVE! is Virginia's opioid overdose and naloxone education program, providing training on recognizing and responding to opioid overdoses using naloxone.

Who can attend a REVIVE! training?

Anyone can attend a REVIVE! training, including community members, healthcare providers, educators, and individuals personally affected by opioid use. This training is not intended for first responders, as they have their own specialized naloxone training. Additional information <u>here</u>.

What will I learn in a REVIVE! training?

Participants will learn how to identify signs of an opioid overdose, administer naloxone, and respond appropriately in an emergency.

How long is a REVIVE! training session?

Training sessions typically last between 60 to 90 minutes.

Is there a cost to attend a REVIVE! training?

No, REVIVE! training is provided at no-cost to participants.

Do I need any prior medical knowledge to take the training?

No prior medical knowledge is required. The training is designed to be accessible to all individuals.

Will I receive naloxone after completing the training?

Yes, individuals who complete the training may receive naloxone at no cost, depending on availability and program guidelines.



How can I find a REVIVE! training near me?

Can organizations request a private training session?

Yes, organizations can request private training sessions. Contact <u>revive@dbhds.virginia.gov</u> to schedule a session.

Can organizations apply for naloxone?

Yes, organizations, community groups, and agencies can apply for naloxone through the Virginia Department of Health (VDH). Visit VDH's <u>website</u> for more information on how to apply.

Is there a certification after completing the training?

Yes, participants receive a certificate of completion after attending a training session.

Can I become a REVIVE! Instructor?

Yes, individuals interested in becoming an instructor can take a Train-the-Trainer session. Contact revive@dbhds.virginia.gov for more details.

Where can I get naloxone outside of training?

Naloxone is available at pharmacies without a prescription in Virginia. Some local health departments and community organizations also distribute naloxone.



Who should carry naloxone?

Anyone who may encounter an opioid overdose, including individuals who use opioids, their family members, friends, and professionals in high-risk settings, should carry naloxone.

Are there additional training resources available?

Yes, REVIVE! offers <u>training modules</u>, including specialized content for teens, healthcare workers, naloxone partners, and public awareness. These modules provide accessible education tailored to different audiences.

How can I support the REVIVE! program?

You can support the program by spreading awareness, attending training, volunteering, or partnering with REVIVE! to host training sessions.
