### **OLD BUSINESS:**

**Harbor Point Behavioral Health Center** –Variance Quarterly Update

Brandon Murrer- Brandon presented for quarter four.

- Restrictions on Freedoms of Everyday Life
  - No complaints or grievances.
  - Average level for the building was 3 of 5

### **New Business**

Advocate Miracle Reed-Thompson completed LHRC training on Restrictions of Freedoms of Everyday Life.

**CLOSED SESSION:**

Motion was made by Cynthia Frazier and seconded by Michelle Logan at 1:17pm that the HPR5 LHRC will go into closed session pursuant to VA code 2.2-3711 (A), for the purpose of discussing confidential information lawfully exempt from public disclosure review to discuss Restriction of Everyday Freedom and conduct LHRC interview.

**RETURN TO OPEN SESSION:**

The committee reconvened in open session at 1:58pm by unanimous vote on a motion by Michelle Logan and seconded by Cynthia Frazier. Each member certified that, to the best of each of their knowledge, only private business matters, lawfully exempted from the statutory open session requirements and identified in the motion by which the closed session was convened, were considered in the closed session, namely for the purposes to discuss a Restriction of Everyday Freedom and conduct LHRC interview.

Recommendation: Motion made by Michelle Logan, seconded by Ms. Cynthia Frazier and unanimously approved by the committee members as follows:

- 1.) Camera restriction was not approved by the LHRC for NW. LHRC recommended that the provider attempt less restrictive alternatives to include:
  - A. Environmental Modifications (tacking dressers to wall)
  - B. Bed Alarm
  - C. Door Chimes
  - D. Moving the unclean clothing items to a different location
  - E. Educating Sponsor on ways to protect Individuals Dignity
  - F. Review NW plan to ensure that all supports are being implemented or needed
- 2.) Camera restriction was approved by the LHRC for MH. LHRC recommended that the provider return with a quarterly update to discuss implementation.
